Thawj qhov no, raws li tus qauv tshiab los ntawm Sacramento County Public Health Department, uas peb yuav qhia tomqab uas peb qhia txog tej yam tshiab, EGUSD yuav rov qab cia cov tub ntxhais mus koom rau tej yam kev kawm (event) lossis kev ua kislav li twb tau muab teem rau hnuv no lawm, Lub Peb Hli 10 thiab Wednesday, lub Peb Hli 11. Peb tseem tos thiab xav kom lawv teb rov tuaj uantej hnuv Wednesday tavsus txog lwm yam kev kawm (event) thiab kev ua kislav seb puas tseem yuav cia lawv ua raws li twb tau muab teem rau lub litiam no lawm.

Qhov thib ob, thaum tavsus no, peb tseem yuav ntsib nrog cov thawj coj (labor leaders) peb vam thiab cia siab hais tias lawv yuav cia peb phav ntawv spring break li twb tau muab tso rau hauv daim calendar lawm.
