# School Facility Conditions and Planned Improvement

This school has 36 classrooms, a multipurpose room, a library, a science lab, and an administration building. The campus was built in 2005.

The district's maintenance and grounds departments work in concert with the school site custodial team to ensure that school buildings, classrooms, and grounds are maintained at exceptional levels to provide a safe and functional environment for all students. The district utilizes the latest electronic work order system enabling site administration and custodians to communicate maintenance needs, urgent repairs, or necessary projects. Emergency repair needs are immediately resolved by either the school custodian or district maintenance staff. The school's custodians work as a team and with the principal to develop a daily cleaning process and schedule. Each morning the custodian inspects the school prior to students and staff entering school grounds. Restrooms are inspected throughout the day to ensure that they are adequately stocked, safe, and sanitary. The Board of Education has adopted cleaning standards for all schools in the district. A summary of these standards is available at the school office, or at the district office.

This year we installed high-quality filters in each classroom and had a small monument build in our quad to commemorate the year 2020.

In the 2019-2020 school year, over 99 percent of the district's teachers held full teaching credentials. In addition to being fully credentialed, if a class is 20 percent or more English Learners (EL), the teacher should hold a supplementary authorization to instruct students in learning English or they are considered misassigned.

In subjects with a shortage, a fully credentialed teacher is sometimes asked to teach outside of their subject matter competency area until an appropriately credentialed teacher can be hired. In these cases, teachers are counted as misassigned.

Vacancies are defined as a position to which a permanent teacher has not been assigned by the beginning of the course. Most vacancies in our district are in subject areas where qualified teachers are in shortage.

In Elk Grove schools, our research shows that small class sizes lead to higher student engagement and academic achievement. It has been a top priority in our district to reduce class sizes. For the 2020 - 2021 school year, class sizes are 24 to 1 in Transitional Kindergarten through 3rd grade, and 28 to 1 in 4th through 6th grades.

#### **Professional Development**

For the 2020 - 2021 school year, Helen Carr Castello Elementary has a professional development emphasis on the Common Core State Standards, Progress Monitoring, Social and Emotional instruction and developing digital learning skills to support our Distance Learning programs.

New teachers who have been teaching fewer than two years are supported by the district's beginning teacher (BTSA) program. They meet regularly with an experienced mentor to discuss their successes, challenges and new ideas for their classrooms.

Finally, the district offers a variety of classes for support staff. Instructional aides, school secretaries, office clerks, and custodians may take classes that relate to their work such as learning new computer skills and learning to work more efficiently and in ergonomically correct ways.

# School Safety Plan

At Helen Carr Castello we believe that nothing should get in the way of learning. The safety of our students is this school's first priority. Our Positive Behavioral Interventions and Supports (PBIS) plan dictates behavioral expectations and positive incentives. We believe that these positive assets make a difference in our students' well-being.

An Emergency Handbook outlining a plan of action for earthquakes, fires, floods, and chemical spills is kept in the office. Emergency drills are conducted monthly. Staff assists with before and after school supervision. The campus gates are locked during school hours. All visitors must register through the front office. Our Safety Plan was updated in December 2020. The district's Police Services Department works closely with our school to provide a safe, secure environment for all students.

# Specialized Programs

At Helen Carr Castello Elementary, we have highly qualified staff members to assist students with specialized learning needs. Our Learning Center services not only special education students, but also general education students who need additional support to meet grade level standards. We support our struggling and/or "at risk" students through our WIN (what I need)groups, mentors, and afternoon school tutoring and small group instruction. Gifted and Talented/Accelerated students participate in differentiated and accelerated instruction during class time, summer school, and in extended day opportunities. We have a National Elementary Honor Society chapter at our school site. This program provides additional opportunities for our top scholars.
