Elk Grove Unified School District (EGUSD) makes great efforts to ensure that all schools are clean, safe, and functional. EGUSD maintenance staff ensures that the repairs necessary to keep the school in excellent condition and working order are completed in a timely manner. A work order process is used to ensure efficient service and that emergency repairs are given the highest priority. Regular inspections are conducted at EHMS by the custodial staff, site supervisor, district maintenance and facilities department, and the fire department. Edward Harris, Jr. Middle School (EHMS) was built in 2004 and is in good-excellent condition structurally.

The LEA takes great efforts to ensure that all schools are clean, safe, and functional. To assist in this effort, the LEA uses a facility survey instrument developed by the State of California Office of Public School Construction. The results of this survey are available at the district office. Included is information from the facility survey instrument on the condition of the school and the efforts made to ensure that students are provided with a clean, safe, and functional learning environment. EGUSD's maintenance department works in concert with the school site custodial team to ensure that school buildings are maintained at exceptional levels to provide a safe and functional environment for all students. The district utilizes the latest electronic work order system, enabling the site to communicate maintenance needs, urgent repairs, or necessary projects. Emergency repair needs are immediately resolved. The school's custodians work to develop a daily cleaning process and schedule. Each morning the custodian inspects the school prior to students and staff entering school grounds. The Board of Education has adopted cleaning standards for all schools in the district. A summary of these standards is available at the school office, or at the district office.

The State Deferred Maintenance Program (DMP) was established in 1980 to aid districts in major maintenance projects. Beginning with the 2013-2014 fiscal year and the inception of the Local Control Funding Formula (LCFF) the State has intended for Deferred Maintenance needs and expenses to be included in the District's LCFF allotment. The district continues to fund routine projects previously considered as part of the State's former DMP at levels required by the State and continues to use local resources.

Previously, the school was able to put up fencing around the perimeter to support our safe campus initiative. The fencing now encompasses the entire school, as well as our neighboring high school Monterey Trail. This initiative leaves zero access for pedestrians, ensuring that our students are safe from external risks. Four years ago, EHMS added a community garden to enhance the aesthetics and learning experience for all stakeholders. That project is now complete with modifications and improvements being made monthly. The garden has become a source of pride for our staff and garden club members. Two years ago a state of the art surveillance system was installed to enhance security measures on campus, and deter undesirable occurrences.

At EHMS, we believe that nothing should get in the way of the academic achievement of our students. An updated "Emergency Handbook," outlining a plan of action for emergencies, such as earthquakes, fires, and lockdowns, is kept in the administration building. This plan is reviewed by the staff yearly. The school is outfitted with a state of the art camera system that monitors the perimeters and interior of the campus. Each quarter, we have school-wide emergency drills. The County of Sacramento conducts random school safety inspections as well. In support of students' safety, campus supervisors, teachers, and administrators are on supervision duty before and after school. Weekly meetings are held with administration and campus supervisors. Before entering the campus, all visitors, including parents, must sign-in and receive a visitor's pass in the Student Services building.

Our priority at Edward Harris, Jr. Middle School is to assist teachers in supporting all students. The Connections Department services students with individualized education plans (IEP), who require additional support to meet mastery of curriculum standards. Gifted and Talented Education (GATE) and honors students receive accelerated instruction. The Advancement Via Individual Determination (AVID) program is vital in preparing students for college. EXL is an after school program that provide students with tutorial/homework sessions and enrichment activities. EXL is held daily until 6:00 pm and staffed by qualified adult mentors. EHMS has tutoring, as well as various clubs offered after school as well.

## Professional Development

Our school and district offer a variety of professional learning opportunities. Workshop topics include California Common Core State Standards, Illuminate, Math Generation, Arbinger, Home Visits, Equity Trainings, EPOCH workshops, Restorative Practices Trainings and workshops for learning academic language strategies for English Learners. Instructional coaches assist teachers in new strategies. EGUSD also offers a variety of training workshops for classified personnel related to their job description. Our school has a weekly early out schedule in which students leave school one hour early on Thursday. Teachers use this time to work in professional learning communities to collaborate, analyze student work, discuss common assessment data results, and identify the most effective instructional practices to meet students' academic needs. This year EHMS has 8 minimum days following progress report time, for teachers to meet with their PLC teams to discuss student outcomes. New teachers who have been teaching less than two years are supported by the district's (BTSA) beginning teacher support program.
