Teacher Credentials and Misassignments

In the 2024-2025 school year, over 99 percent of the district's teachers held full teaching credentials. In addition to being fully credentialed, if a class is 20 percent or more English Learners (EL), the teacher should hold a supplementary authorization to instruct students in learning English or they are considered misassigned.

In subjects with a shortage, a fully credentialed teacher is sometimes asked to teach outside of their subject matter competency area until an appropriately credentialed teacher can be hired. In these cases, teachers are counted as misassigned.

Vacancies are defined as a position to which a permanent teacher has not been assigned by the beginning of the course. Most vacancies in our district are in subject areas where qualified teachers are in shortage.

School Facility Conditions and Planned Improvement

This school has 36 classrooms, a multipurpose room, a library, and an administration building. The main campus was built in 1957. A new multipurpose room was constructed in 1991. New classroom complexes were constructed in 2006. Two classrooms were modernized in 2011. A shade structure was added to the playground in 2020. Our school underwent a complete refresh during the summer of 2024 - which included new flooring, lights, and paint both inside and outside of all buildings on campus.

The District's Maintenance and Grounds Department works in concert with the school site custodial team to ensure that school buildings and grounds are maintained at exceptional levels to provide a safe and functional environment for all students. Emergency repair needs are immediately resolved by either the school custodian or district maintenance staff. The school's custodians work as a team and with the principal to develop a daily cleaning process and schedule. Each morning the custodian inspects the school prior to students and staff entering school grounds. Restrooms are inspected throughout the day to ensure that they are adequately stocked, safe, and sanitary. The Board of Education has adopted cleaning standards for all schools in the district.

During the 2016-2017 school year, our playground equipment was updated with new bridges and poles. The roofs of our older wings were replaced in 2018 and 2019. Our school received a new shade structure on our playground during the summer of the 2019-2020 school year. A school refresh was completed during the summer of 2024 which included all new flooring, lights, and paint throughout the school.

For the 2024 - 2025 school year, class sizes are 24 to 1 in Transitional Kindergarten through 3rd grade, and 28 to 1 in 4th through 6th grades.

Professional Development

Our teachers use Professional Learning Communities to implement research-based strategies, which have a positive impact on our students' academics as well as their emotional well-being. Grade level teams are provided with regular articulation during our Early Out days to review assessment data, make determinations about students' strengths & weaknesses, and plan subsequent instruction to meet our students' needs.

Our teachers also take part in a district professional development program that is intended to increase teacher knowledge of best academic practices, including Saturday Seminars and workshops in English Language Arts and Math. Additionally, special education teachers have numerous opportunities to learn how to best meet the needs of students with learning disabilities.

The district also offers classes for support staff. Para-educators, secretaries, office assistants, and custodians may take classes that relate to their work such as learning new computer skills, supporting students in the classroom, and safety procedures.

All school employees have begun a sequence of two-year trainings in the area of Diversity, Equity and Inclusion.

School Safety Plan

We are committed to providing a safe and secure environment for learning before school, during the school day, and after school. Our staff reviewed and updated our School Safety Plan in September 2024. An Emergency Handbook, outlining a plan of action for emergencies such as earthquakes, fires, floods, and chemical spills, is kept in the school office and in each classroom. Random, periodic school safety inspections are conducted by the County of Sacramento. The district's Police Services Department works closely with our school site to provide a safe, secure environment for all students. We ensure close supervision of students from 7:50 am until they return home from school. Our campus is fully gated, and all visitors must enter through the office, sign-in and display a visitor's badge while on campus.

Specialized Programs

We have highly qualified staff at our school to assist students with special learning needs. Our Learning Center staff services special education students who need additional support to meet standards, as appropriate. Bilingual Teaching Associates help our English Learners access the core curriculum. We also offer extended day programs, such as winter or spring Intersession, English Learner Programs, Champions After School Program, band, and extracurricular activities such as co-ed basketball, co-ed volleyball, co-ed chess, co-ed cheerleading and co-ed flag football. In addition, our school has numerous Academic Intervention Teachers who assist struggling students.
