Teacher Credentials and Misassignments

In the 2024-2025 school year, over 99 percent of the district's teachers held full teaching credentials. In addition to being fully credentialed, if a class is 20 percent or more English Learners (EL), the teacher should hold a supplementary authorization to instruct students in learning English or they are considered misassigned. In subjects with a shortage, a fully credentialed teacher is sometimes asked to teach outside of their subject matter competency area until an appropriately credentialed teacher can be hired. In these cases, teachers are counted as misassigned.

Vacancies are defined as a position to which a permanent teacher has not been assigned by the beginning of the course. Most vacancies in our district are in subject areas where qualified teachers are in shortage.

School Facility Conditions and Planned Improvement

Laguna Creek High School has 88 classrooms, five computer labs, a black box theatre, a weight room, the main gym, an auxiliary gym, a dance room, a multipurpose room, a library, a career center, a counseling center, and an administration building. The main campus was built in 1994. Five portable classrooms were added in 1997 for growth, with ten more added in 2000. The campus has two baseball fields, two softball fields, a fieldhouse with athletic lockers, an all-weather turf field, and a track. CTEIG funds were used to expand the Sports Career Academy lab to include hydrotherapy. Our campus is undergoing modernization during 2024-2025.

The district's maintenance and grounds departments work in concert with the school site custodial team to ensure that school buildings, classrooms, and grounds are maintained at exceptional levels to provide a safe and functional environment for all students. Repair needs are immediately resolved by either the school custodian or district maintenance staff. The school's custodians work as a team and with the principal to develop a daily cleaning process and schedule. Each morning, the custodian inspects the school prior to students and staff entering school grounds. Restrooms are inspected throughout the day to ensure that they are adequately stocked, safe, and sanitary.

With the passing of Measure M, Laguna Creek High School will see modernization projects over the next several years. Modernization work is ongoing and concludes in Summer 2025.

Career Technical Education Programs

Career Technical Education (CTE) provides opportunities for LCHS students to prepare for college, career and life through a Linked Learning approach that integrates rigorous academics, technical skills, relevant real-world experiences, work-based learning opportunities, and wrap-around student support to help students develop the 21st-century skills and habits of mind they will need to succeed after graduation. Guidance/career counselors and advisers offer additional support. In weekly Advocacy for example, classes at each grade level focus on achieving the outcomes described in the EGUSD Graduate Profile. Lessons include transcript review, college readiness, A-G completion, course selection, Academy applications, college admissions, and how to access resources within the school and surrounding community. LCHS is an authorized International Baccalaureate Middle Years and Diploma Program World School and a Candidate School for the IB Career-related Programme.

LCHS offers the following programs that promote leadership, develop job-related skills, offer work-based learning opportunities, and increase interest in school: California Partnership Academies (CPA), High Quality Career Pathways (HQCP), and Explore CTE Programs. CPAs feature cohort scheduling in CTE and academic core classes, integrated projects, and work-based learning opportunities. All CTE programs have an advisory committee of industry representatives for guidance and input. CTE programs at LCHS also allow students to meet graduation requirements and complete A-G requirements through courses that incorporate state-adopted academic standards. In 2021-22, LCHS offered three CPAs, Manufacturing Production Technology Academy, Sports Careers Academy, and Green Energy Technology Academy. HQCPs included Computer Science and emerging Design pathways. CTE programs at LCHS offer opportunities for student leadership development, including HOSA in the Sports Careers Academy and student leadership teams in both GETA and MPTA.

Individual student assessment of work readiness skills in CTE programs through end-of-course exams, such as National Association of Sports Medicine Personal Trainer Certification, OSHA 10 Certification, Woodwork Career Alliance Sawblade Safety, Red Cross First Aid and CPR, projects, and other means.

Professional Development

For 2022-2023, our school continues to have a professional development emphasis on using professional learning communities, student engagement, and IB Instructional methodology. LCHS will be evaluated by WASC & IB in November 2023 for programme evaluation. The Synchronized Visit is scheduled to occur in November 2023. Teachers attend weekly early-release PLC Collaborative Team meetings. Teachers use this time to meet and review student work, determine students' strengths and weaknesses, and plan subsequent instruction to meet students' needs. Our school also receives LCFF funding that provides money for professional learning and supplementary student resources. We continue to have four collaborative IB MYP minimum days to work with HEMS.

Teachers continue to be trained in IB methodology as we expand the number of staff trained to teach in the IB Diploma Programme and MYP Programme.

School Safety Plan

In addition to 6 Campus Supervisors, LCHS employs a School Resource Officer in partnership with the Elk Grove Police Department. Supervisors are staggered throughout the day to ensure supervision from 7:00 a.m. to 5:30 p.m. The Safety Plan was last reviewed in November 2024. An "Emergency Handbook," outlining a plan of action for emergencies such as earthquakes, fires, floods, etc., is kept in the school office. "Emergency Flipcharts" are in every classroom and non-teaching space on campus. Emergency procedures are also included in substitute packets. Security staff monitors all after-school events, such as games and dances. The district's School Safety and Security Department works closely with our school site to provide all students a safe and secure environment. Visitors are required to check in through the administrative office.

Specialized Programs

LCHS has highly qualified staff to assist students with special learning needs. Our English Learners receive support in transitional classes, allowing them to access the core curriculum, and are placed in classes to learn English as needed. Gifted and Talented students participate in Honors courses, our International Baccalaureate Middle Years and Diploma Programmes, and Advanced Placement courses. Students who need extra tutoring or homework help can receive departmental help from individual teachers. The Library is open daily after school from 8:15-3:30 p.m. and Career Center is open 8-3:45 p.m. Other special programs offered include Manufacturing Production and Technology Academy, Computer Science, Design Institute, Sports Career Academy, Green Energy Technology Academy, and AVID.
