The Board of Education is requested to hold a public hearing and approve the General Waiver Request to the California Department of Education for the Elk Grove Charter School Non-Classroom Based Funding Determination.

Discussion:

Elk Grove Charter School operates as an independent study program. In order to receive state funding as a non-classroom based instructional program we are required to submit a non-classroom based funding determination calculation to the California Department of Education (CDE) for the State Board of Education (SBE) to approve.
