**Approval of Contract with Search Firm for Superintendent, Elk Grove Unified School District** – Motion No 10, 2014-15

Motion by Ms. Singh-Allen and seconded by Mr. Ly that the Contract for Services with McPherson & Jacobson L.L.C. to serve as consultant for the District's superintendent search be approved. Roll Call Vote: Ayes – Amavisca, Ly, Madison, Perez, and Singh-Allen; Noes – None; Abstain – Cox; and Absent – Forcina.

The contract is in the amount of \$29,900 plus expenses for advertising the vacancy, reasonable office expenses for the search, telephone charges for reference checks and screening candidates, travel and expenses of consultants for all trips to the District; and criminal/financial background checks on candidates.

### **Establishment of Search Process**

Mr. Bill Huyett and Mr. Bob Ferguson, consultants with McPherson & Jacobson, reviewed with the Board the terms of the contract relating to the search process. Also reviewed were the timeline; advertising plans; stakeholder, employee group, District advisory, and community meetings that will be held.

Tentatively scheduled are a meeting to be held September 2, or another evening, to review stakeholder input and finalize the interview schedule, schedule two or three meetings September to interview applicants, and hopefully September 9 to make the decision regarding employment of a superintendent.
