OPEN SESSION – Ms. Singh-Allen called the regular meeting to order at 6:00 p.m. and announced that the Board met in closed session and that no action was taken on Item 1 and Items 3 through 6. For Item 2, the Board voted 5 in favor and 0 against with two board members absent (A. Perez and C. Madison) in favor of placing a certificated employee on compulsory leave.

I. Pledge of Allegiance

Mrs. Teresa Mejorado who was accompanied by her husband Daniel and their three children, all of whom attend James McKee Elementary School led the pledge of allegiance and they were recognized by the Board of Education. II. Presentations/Recognitions

- 1. High School Representative Reports: Florin and Rio Cazadero High Schools Students from both Florin and Rio Cazadero High School reported on activities and academics at their schools.
- 2. Academic Decathlon Student and Teacher Recognition The Board of Education recognized students and coaches who earned recognition at the 36th Annual Sacramento County Academic Decathlon competition. This year, two Elk Grove Unified School District high schools placed in the "Top 10" among competing schools. They are: Pleasant Grove High School 3rd Place Overall and Sheldon High School 6th Place Overall.
- 3. California Poetry Out Loud Competition The Board recognized and commended the 2016 California Poetry Out Loud winner from Pleasant Grove High School for placing first in state competition. Chigozie Maduchukwu, a junior from Pleasant Grove High School won the 2016 California Poetry Out Loud competition on Monday, February 29, 2016 at the state Capitol, earning him a trip to Washington, D.C. to represent California in the national finals in May. This is the first time in eleven years of the state competition that a student from Sacramento County has won.



1. Indian Education Program Update – Sonjhia Lowery provided an update about the Indian Education Program for Native American and Alaskan Native students and their families.

The Indian Education program has strong connections to the Native American community in the Sacramento region and beyond, and is recognized widely as a leader in innovative programming for Native American children. The program provides important educational services to American Indian and Alaska Native children, and their families, to ensure students' academic success. These services include one-on-one and small group tutoring assistance, presentation of Native American cultural classes during the regular day, after school and during summer, and outreach to parents of students who have not met grade level requirements or who are at risk.

The program has been redesigned to include unrecognized, disenrolled and self-identified students and families, which were previously unserved. Since each tribe is a unique nation, rules for enrollment vary widely. These students are ineligible for our federal grant Title VII services. Support has been built in for them through our Local Control Funding and community partnerships. The American Indian Education program has welcomed these students and families into the program and the district has found collaborative ways to serve them.

2. Advancement Via Individual Determination (AVID) Presentation — Ms. Tina Penna and Mr. Ralph Robles provided an update about the AVID program in the Elk Grove Unified School District. AVID addresses college readiness for students, particularly those who would be first-generation college-goers. Each middle and comprehensive high school in the district offers AVID, which currently serves over 3,000 students district-wide.

X. Public Hearing/Action Items

1. Consideration and Public Notice of ATU's Initial Proposal to the District Regarding Collective Bargaining for the 2016-17 School Year - Mr. David Reilly provided information about ATU's initial proposal to the Elk Grove Unified School District regarding Collective Bargaining for the 2016-17 School Year.

There were no responses to the call for a public hearing on the proposal.

Motion No. 99, 2015-16 – Motion by Ms. Albiani, seconded by Ms. Martinez-Alire, and carried unanimously by an affirmative vote of all Board members present, that ATU's initial proposal to the Elk Grove Unified School District Regarding Collective Bargaining for the 2016-17 School Year be accepted.

2. Consideration and Public Notice of Elk Grove Unified School District's (EGUSD) Initial Proposal to AFSCME Regarding Collective Bargaining for the 2016-2017 School Year - Mr. David Reilly presented Elk Grove Unified School District's Initial Proposal to AFSCME regarding Collective Bargaining for the 2016-17 School Year.

There were no responses to the call for a public hearing on the proposal.

Motion No. 100, 2015-16 – Motion by Ms. Chaires Espinoza, seconded by Ms. Martinez-Alire, and carried unanimously by an affirmative vote of all Board members present, that Elk Grove Umified School District's Initial Proposal to AFSCME regarding Collective Bargaining for the 2016-17 School Year be approved.

XI. Discussion Items

1. Local Education Agency Plan – Ms. Sonjhia Lowery presented information and requested that direction and input be provided regarding the recent revisions to the District's Local Education Agency (LEA) Plan. The Elk Grove Unified School District is required to rewrite the LEA Plan every five (5) years.

The LEA Plan is a:

- blueprint for students to achieve the state content standards;
- single, coordinated, and comprehensive plan describing services for all students;
- basis for a continuous cycle of assessment, parent and community involvement, planning, implementation, monitoring, and evaluation;
- summary of all existing federal and state plans that can establish a focus for raising academic performance for all students;
- yearly update of LEA program implementation;
- guide to implementing federal and state-funded programs, allocation of resources, and reporting requirements.

In developing this plan, input has been received from various stakeholders. This plan meets the compliance requirement set forth by the California Department of Education (CDE). This item will be brought back for approval at the regular meeting of the Board of Education on April 5, 2016.

XIII. Action Items

1. EGUSD Community Facilities District No. 1 Special Tax Bonds Outstanding Bond Refunding Opportunity and New Moncy Borrowing – Mr. Robert Pierce provided an overview of the presentation from February 16, 2016. On February 16, 2016 staff and Government Financial Strategies Inc. presented an extensive report on a potential opportunity to refund/refinance up to three outstanding bond series under Community Facilities District No. 1 (CFD #1) as well as an opportunity to issue new money in order to construct two necessary and priority elementary schools.

The District has outstanding special tax bonds issued via CFD #1 totaling just over \$175 million. Of the outstanding bonds approximately \$78 million are eligible for early repayment (callable) while at the same time the rates on these three outstanding series of bonds are sufficiently high enough, relative to the current market, to warrant an opportunity for an efficient refunding and significant savings. The opportunity for significant debt service savings has transpired due to the fact that municipal bond rates are at historically low levels while at the same time certain outstanding bonds are callable. Meanwhile the District has a need for approximately \$30 million in new money for the purposes of constructing two priority elementary schools. The savings achieved through the refunding warrants the District an opportunity to issue new money to be partially repaid with the savings realized through the refunding.

The resolution authorizing the sale of Certificates of Participation (COP's), to be used for the refunding and new money, includes a minimum savings provision as a protection measure, which only allow the COP's to be sold and bonds to be called and refunded if an

acceptable minimum level of savings is achieved through a competitive bid for the sale of the COP's. The District is using the Board-approved services of Government Financial Services Inc., as the financial adviser and Lozano Smith Attorneys at Law, as bond counsel.

This potential opportunity to refund outstanding bonds would generate significant debt service payment savings on an annual basis for up to 23 years while creating a new money opportunity of \$30 million to use for needed capital projects. Financial adviser fees, underwriter's discount, and bond counsel fees are payable from the proceeds of the COP's.

Motion No. 101, 2015-16 – Motion by Ms. Chaires Espinoza, and seconded by Mr. Forcina, and carried unanimously by affirmative vote of all Board members present that Resolution No. 48 authorizing the delivery and sale of Certificates of Participation to finance capital facilities of the District be adopted and approved related documents and also authorized staff to finalize the resolution and related documents based on the terms and conditions of the sale of Certificates of Participation.

2. Charter Petition from California Montessori Project – Ms. Kathy Hamilton provided information about the Charter Petition from the California Montessori Project. On January 19, 2016, the EGUSD Governing Board received a renewal petition from California Montessori Project (CMP) to renew its Elk Grove Charter School. At the March 1, 2016, meeting, Director of College and Career Options Kathy Hamilton presented a preliminary report outlining findings of fact as identified by staff who reviewed the renewal petition. She noted that EGUSD has identified one corrective action and is working with CMP to clarify several other areas, but that the petition otherwise meets guidelines for renewal identified in Education Code. Ms. Hamilton also informed the Board that a Memorandum of Understanding describing the operational agreements between EGUSD and CMP will be developed and presented for approval at the regular board meeting on April 5, 2016.

Motion No. 102, 2015-16 – Motion by Mr. Forcina, and seconded by Ms. Chaires Espinoza, and carried unanimously by affirmative vote of all Board members present that the California Montessori Project's Charter School Renewal Petition for its Elk Grove school be approved.
