- 1. High School Student Representative Reports - Elk Grove, Las Flores, and Valley High Schools** – Students from Elk Grove, Las Flores and Valley High Schools reported on activities and academics at their schools.
- 2. Kids Can Food Drive Recognition** – Elk Grove Unified School District schools provided a total of 81,136 pounds of food to the Elk Grove Food Bank. The following schools were commended for their winning donations to the 2018 Kids Can Food Drive:

V. Public Comment

Lili Devaney voiced her concerns about a bullying incident at her son’s school and the series of events with the vice principal and coach that led up to her son being blamed for the incident. She requested that schools do more to assist with bullying.

Leo Estrada and Myra Sandoval expressed their concerns about the VHS soccer team being pulled out of class early on game days to play their games on campus before it gets dark. They both requested that the team be allowed to play on the Cosumnes River College campus because CRC has a lit field and their students wouldn’t need to miss class time on game days.

Laura Delight, Tim Kamermayer, Nicolas Boa, Aman Dhillon, Gurprit Hansra and Tyler McCurley shared their views and spoke in support of the History/Social Science curriculum.

Sue Spillman, Elda Ortiz, and Raymond Kemp shared their views and spoke in opposition of the adoption of the proposed K-8 History/Social Science Curriculum.

Leticia Gilmore shared her concerns about a bullying incident involving her son who was bullied at school. Ms. Gilmore also voiced her concerns about some of the campus supervisors and suggested better interventions.

Doreen Singh shared her concerns about the lack of support she received from the principal at the school site after her 12 year old niece was brutally attacked by another student. Ms. Singh requested that parents be held accountable for their bullies and that better assistance be provided to the victims.

Charles Taylor spoke on behalf of a Franklin High School parent and shared her concerns and frustrations about an incident on campus that involved her daughters.

Carol Rogers asked the Board how security guards are hired and what training they receive and what qualifications they need to meet to become employees of the Elk Grove Unified School District. Ms. Rogers thanked the District and Mark Cerutti for leading the PARSS group and hopes to see good benefits on all campuses.

Tyra Purcell shared her concerns about the bullying of her daughter at her school. Ms. Purcell stated that she has tried to work with administration on several occasions, but doesn't feel it helped. Ms. Purcell also stated that she felt that the Stop Walk Talk program puts too much responsibility on the victims and not enough on the adults and requested it be looked into.

The cost of this new instructional material is planned for and budgeted in a multi-year textbook budget within the Curriculum and Professional Learning Department. Based upon projected student numbers and projected costs of the instructional materials, \$5,491,750 has been allocated for this expenditure.
