Live public comments via Zoom audio:

Becky Crozier thanked the Board for the progression in getting kids back in school and has noticed a difference in her children. Ms. Corzier shared her concerns about the possibility of Distance Learning being a main option. Concerned that there isn't a solid plan for the new school year. Requested a communication be sent out to alleviate fears that some parents may be having of the possibility of Distance Learning being a main option for next year before June 15<sup>th</sup>. Ms. Crozier asked that school should be 5 full days a week for new year.

Joel Boyd, representative of the parent coalition, shared that on March 23<sup>rd</sup>, Ms. Chaires Espinoza agreed with Trustee Forcina and made a motion that was unanimously approved by board members to hold a public discussion about school returning 5 days a week. Mr. Boyd shared his concerns about the 5 day a week option not being on the board meeting agenda and about the current model and requested the item be placed on a board meeting agenda for agenda for discussion.

Loreen Pryor shared her concerns about the disproportionate discipline numbers in the district and asked that there be a discussion about directing resources to programs for black students using CARES act monies. Ms. Pryor stated that for multiple years she has come before the Board requesting to discuss the disproportionate discipline numbers amongst black children in the District and her requests have been unanswered. Ms. Pryor asked that someone be designated to reach out to her to have the discussion.

Mark Cerutti provided the Board with an update on the Illuminate Student Assessment System including benefits to students, teachers, teacher and administration training, assessment development, and reporting features. The Illuminate online student assessment system was purchased in 2018-2019 school year. Work has been underway to introduce the system to classroom teachers, site administrators, instructional coaches, and district administrators. EGUSD uses a balanced student assessment model that includes diagnostic, formative, interim, and summative assessments to support both student learning and determine academic progress. Illuminate is a valuable tool that can support individual teachers, teams of teachers, schools, and the district in supporting the cycle of teaching and learning to determine strategies for academic intervention, designing opportunities for enrichment, and professional development.

The glare created exceeds that that may be observed in a typical shopping center such as the shopping centers located at Laguna and Franklin. Light continues to travel unless interrupted by an object or diffuses though air dispersion – for example sunlight travels about 93 million miles as we teach our children. Therefore care is required to determine light direction, distance and impact when mounting floodlights on the exterior of a building to not create nuisance though light pollution. The issue for me is even though my house is approximately one-quarter mile from the light source at the school, the lights create the appearance that headlights are pointed at my windows and the light is intense enough to create shadows within my house.
