**NEW COURSE REQUESTS:**

**American Sign Language II** (World Language, Grades 9-12) (one-year equivalent, 10 credits) In this course, students will learn the language by watching (receptive skills) and responding (expressive skills), increasing their abilities acquired from ASL I. Students will learn to use the language through continuous exposure to both receptive and expressive ASL. Students will continue to learn to sign about themselves and others, requests, opinions, and storytelling. The class will be conducted using the target language and will expose students to Deaf Culture and the Deaf Community to be able to communicate appropriately and effectively about the various Level II topics.

**Entrepreneurship II** (CTE Elective, Grades 10-11) (one-year equivalent, 10 credits) This course provides a survey of all business areas, including accounting, law, human resources, management, marketing, economics, and finance. The course is designed to be taken by students interested in business.

**IT Support Specialist** (CTE Elective, Grades 11-12) (two-year equivalent, 20 credits) This year-long, 20-credit course prepares students for careers in computer technical support. Students have the opportunity to gain the Google IT Support Professional Certificate along with additional cybersecurity skills through Project Lead the Way Cybersecurity curriculum. Students will also participate in Essential Skills and Application Skills training to learn how to navigate the workplace and obtain employment.

Pre-Requisite(s): None

**Biology of the Living Earth, Newcomer English Learner** (EL Science, Grades 9-12) (one-year equivalent, 10 credits) This laboratory course provides English learners in a Newcomer Program a foundation for the biological and earth sciences. Topics include ecosystem interactions and energy, history of Earth's atmosphere, evidence for evolution, inheritance of traits, structure and function, and ecosystem stability, and the response to climate change. This course integrates ELD standards-based instruction to include a focus on academic vocabulary, expository writing, and expository reading of science texts. (See NGSS Performance Expectations & Disciplinary Core Ideas.) Instructors use a variety of scaffolded instructional techniques focusing on listening, speaking, reading, and writing to address the specific needs of Newcomer English Learners. This

course emphasizes developing conceptual models through asking questions, analyzing data, designing and carrying out experiments, and designing solutions to real-world situation.

**Physics of the Universe, Newcomer English Learner** (EL Science, Grades 10-12) (one-year equivalent, 10 credits) This laboratory course addresses the relationships of physics in the universe for English learners in a Newcomer Program. Emphasis is on observing phenomena, gathering and interpreting data, developing models, discovering graphical and mathematical relationships, and engineering and refining solutions to realistic problem scenarios. This course integrates ELD standards-based instruction to include a focus on academic vocabulary, expository writing, and expository reading of science texts. (See NGSS Performance Expectations & Disciplinary Core Ideas.) Instructors use a variety of scaffolded instructional techniques focusing on listening, speaking, reading, and writing to address the specific needs of Newcomer English Learners. This course includes units on motion and forces, energy conversions, waves and electromagnetic waves, nuclear processes, and stellar processes.

## UPDATE/REFRESH TO AN EXISTING COURSE:

**AP Computer Science A** (Course #07513) (Computer Science, Grades 10-12) (one-year equivalent, 10 credits) This course is equivalent to the first semester of a college-level course in computer science. The course introduces problem-solving and programming using Java. The topics in this course include program class design, implementation techniques, programming constructions, java library classes, and interfaces included in the AP Java subset, testing, debugging, runtime exceptions, program correctness, algorithm analysis, primitive data types, strings, classes, lists, one and two-dimensional arrays, sorting, searching, and operations on data structures. A minimum of 20 hours for hands-on lab experiences are also part of the course. This course is accepted by UC/CSU as a 4<sup>th</sup> year math course.

Series 2021 Bonds: Issuance and sale of General Obligation Bonds, Election of 2016, Series 2021, of Elk Grove Unified School District in the aggregate principal amount of \$140,500,000** - Ms. Albiani called on Xanthi Soriano for public comments submitted through the District's Public Comment Form related to this item; there were none.

Rob Pierce provided the board with a report regarding the sale of Measure M Bonds that occurred on April 6, 2021. On November 8, 2016 the electorate approved Measure M, authorizing the issuance and sale of general obligation bonds of the District in an amount not to exceed \$476,000,000. Consistent with the parameters prescribed by Resolution No. 54, 2020-21, the District successfully sold the third series of Measure M bonds in the amount of \$140.5 million and the sale resulted in a significantly lower cost than budgeted in the previously presented and original bond series and structuring plan.

Thank you to the Board and Mr. Bill Hartin of EGUSD for the prompt response on correcting the offending situation. I had to be persistent to get the issue addressed. There may be other impacted individuals that may not know how to raise an issue of light pollution.</p> <p>So to be clear – light pollution is pollution and trespass. The mantra of the Board should not be that “we are going to pollute and trespass, and then when someone complains we will stop the pollution and trespass.” The mantra of the Board should be not to pollute and trespass in the first instance. If one can see glare from a property line, it is an indication that lights are not properly installed.</p> <p>While analysis is required to determine applicability, provided is a link to the Elk Grove Municipal Code on lighting that has as its intent to limit nighttime glare. Links are also provided to the Kern County Code because it has good illustrations, and the San Bernardino Land Use Services Division draft report on Light Trespass from February 2021 as informative.</p> <p>Recommended is that the Board provide any and all resources to EGUSD to inspect and adjust lighting as needed to prevent or abate light pollution. A metrics progress report posted on the EGUSD website would be nice to keep the public informed. I made my selections, but received no notice of confirmation or an email as to which session I may attend. Yesterday, I received two more notifications asking me to make my selections, I responded yet again. It is now the day before the meetings, I have not received ZERO communication. This hardly feels like a true intent of inclusion. At this late date and the current offering of meeting hours, it is unlikely that I will actually be able to attend since I have a job which requires me to be present and in person. Further, if parents do not attend, we may once again be accused of not "availing" ourselves of the opportunity to participate.</p> <p>Is it your intent to include parents as representatives of their children--your students? If so, then a true committee meeting should be held during the evening hours when parents are able to attend. I look forward to an additional meeting time being offered.</p> <p>The time is ticking away on this school year, I implore you, our children NEED to be in the classroom five full days a week with transportation offered to students who are unable to get there. The two or four mornings a week currently being offered is not adequate to provide the academic and social growth our children's developing minds need. The 34% return to in-person instruction rate should alarm you! Where are the rest of your students? Are their academic and social needs being met? Answer these questions truthfully and get our kids back to school!</p>

Because our numbers of in person learners are so high on our campus, this 30 minute one-on-one test does not allow for an equitable distribution of our instruction time.</p> <p>We understand the desire to secure as much funding as possible, however, administering this assessment at this point in time, takes away from the short amount of time we have with our students – both daily and for the rest of the year. While our goal is to create independent learners, having 20+ kids in the classroom forces this test to be given outside the boundaries of our contract. So many teachers do not feel confident or have had ample time to familiarize themselves with this assessment and yet are now forced to give it with very little notice. We have been bombarded with change in the last two months. As a Kindergarten teacher, I am having difficulty understanding the mandated assessments this late in the year. Teachers received clearance for the entire year on September 28th from the district. In the email states, "For the 2020-21 school year EITHER the Recommended Interim Assessments for the 2020-21 school year OR the Benchmark Assessments from the 2019-20 school year may be used..... During COVID-19 the thinking is to "require" fewer assessments and give teachers the flexibility to choose their own method of assessment for many items on the report card.". The email that was sent from the district, last week goes completely against what we have been previously instructed.</p> <p>I would like to say that panic has now ensued, but it has already been there. Asking Kinder and 1st-grade teachers to assess in a 2-hour window, and 2nd-grade teachers to assess while teaching concurrent has already made us anxious. Now we are being told to use a testing platform that many of us have not used this year (Illuminate) and to give different assessments. I can speak for Kindergarten when I say, these assessments are not aligned with our standards and our report card. We have not been given time to work with the assessment, or to be fully trained on Illuminate. We do not have time in our day to add something new.</p> <p>In addition, we are being told that our fabulous site coach will be available to help us. That's wonderful! But, I don't think the district realized that this one person will be responsible for 3 grade levels at 3 different sites. We have approximately 100 kindergarteners enrolled, 100 1st graders, and 125 2nd graders. That's 325 students at our site, times 3 sites. Our coach is expected to assist with an average of 975 total students at 3 sites?! How is this possible?</p> <p>How about our testing window? For the Modified Traditional Kindergarten schedule, we have 8 weeks left of school, but only 6 weeks left to assess. In those 6 weeks, we are still teaching the basics of how to be students. We are teaching how to hold a pencil, how to raise your hand, how to get supplies out each day, and so much more. We can barely get through 2 activities each day. How are we supposed to assess? Our site coach cannot be everywhere at once.</p> <p>The Illuminate program is not a flawless platform. The assessments have not been created by teachers who are currently teaching Kindergarten, First, or Second grade. The tests are not aligned with how teachers have been teaching. This is a program that we are rushing to use, instead of addressing the issues and listening to teachers.</p> <p>We have been told to put it on a timesheet if we need to add extra hours. I don't have enough hours in a day to do this. I work until 5:30 most nights as is, not including the additional planning I do on weekends or materials I have to bring home to prep. I need to be a parent after 5:30. I have put my life on hold for my job this year. If this isn't the time to say, "Enough is enough!", when is?</p> <p>We have been asked to do the impossible this year and we have done that. Now we are being asked to do it again. I can't. I'm spent.</p>
