As a condition of funding all Districts and Charter Schools are required to submit a Board approved plan for the use of the American Recovery Plan Act - Elementary and Secondary School Emergency Relief (ESSER III) Grant funds. The available funding is \$191 million and will expire June 30, 2024. Staff recommended developing actions and services that will benefit students starting in January 2022 through June 2024.
