I. Pledge of Allegiance – Dr. Kristen Coates, Deputy Superintendent, Business Services and Facilities, led the pledge of allegiance.

III. Reducing Exclusionary Discipline – Mark Cerutti and district staff provided the Board of Education with a multi-year (2018/19-2022/23) comparative analysis of first semester student suspensions and addressed the actions being taken at the district and school levels.

Student discipline policy, practices and outcomes are a Board of Education and District priority. In 2018, specific action was taken by the Board to develop and update policies related to student discipline, including specifying the distinctive roles site administrators and law enforcement have in the student discipline process and taking specific action to move away from zero-tolerance policies and practices to a more developmental/educational model of student discipline.

The actions the District has taken have significantly reduced the number and rate of suspensions. The presentation provided district-wide data for all students as well as disaggregated data specific to the three student subgroups disproportionately impacted by suspensions:

- Students who identify as Black/African American
- Students with disabilities
- Students in foster care

Board members provided feedback and thanked everyone for the update.
