CLASS TITLE: SUPERVISOR - TRANSPORTATION

BASIC FUNCTION:

Under the direction of the Manager-Transportation Operations, schedule, coordinate and supervise the scheduling and dispatch of bus routes, field trips and extracurricular events; supervise the District's Bus Driver training programs and activities; prepare and maintain accurate records related to vehicles and drivers; assign and review the work of drivers; train, supervise and evaluate the performance of assigned staff.

ESSENTIAL FUNCTIONS:

Schedule, coordinate and dispatch buses for bus routes, field trips and extracurricular events; prepare and assign work schedules; prepare bus routes and schedules; initiate and develop programs for proper coordination and utilization of District equipment and personnel.

Prepare and maintain accurate records related to vehicles and drivers; assure proper licenses for subs and drivers and maintain accurate records of expiration dates.

Train, supervise and evaluate the performance of assigned staff; recruit, interview and assist in the selection of employees and recommend transfers, reassignment, termination, and disciplinary actions.

Supervise, coordinate, develop, evaluate, and schedule the school bus driver training program; participate in the instruction of drivers for original and renewal licensing.

Assist Manager-Transportation Operations in planning, developing, supervising, and coordinating safety in-service and classroom workshops.

Maintain and prepare a variety of records and reports.

Communicate with parents and teachers and resolve issues or concerns as needed; resolve and respond to parent complaints.

Make field decisions and recommendations regarding adverse weather, road, bus stop conditions and student safety issues; supervise, coordinate, and evaluate the bus evacuation safety program.

Assist Manager-Transportation Operations in the development of District policies, regulations, and department procedures.

Operate a computer and assigned software.

Coordinate the school bus roadeo program.

Perform related duties as assigned.

DEMONSTRATED KNOWLEDGE AND ABILITIES:

Supervising, training, dispatching, scheduling and coordination of the transportation program.

Proper operation of school buses.

Principles and practices of supervision and training.

Applicable traffic and student transportation laws, codes, and regulations.

Operation of a computer and assigned software.

ABILITY TO:

Schedule, coordinate and supervise the dispatch of buses for bus routes, field trips and extracurricular events.

Prepare and maintain accurate records related to vehicles and drivers.

Train, supervise and evaluate personnel.

Estimate and requisition supplies and equipment.

Drive a school bus safely and efficiently.

Maintain safe discipline level among passengers.

Apply and interpret District policies and procedures related to student discipline.

Observe legal and defensive driving practices.

Effectively read and interpret maps.

Administer first aid to ill or injured children.

Effectively communicate to exchange and understand information.

Establish and maintain cooperative and effective working relationships with others.

Effectively operate keyboard equipment and assigned software.

Work independently with little direction.

Maintain consistent, punctual, and regular attendance.

Sit for extended periods of time.

Bend at the waist, kneel or crouch.

Reach, push and pull to open bus doors.

Drive a vehicle to conduct work.

Work extended hours (nights/weekends) as needed.

EDUCATION AND EXPERIENCE REQUIRED:

High School diploma or equivalent and three years experience in dispatching, scheduling, bus driving, transportation, or fleet operations work.

LICENSES AND OTHER REQUIREMENTS:

Positions in this classification are required to possess a valid California Class B driver's license with passenger endorsement and California School Bus Driver's Certificate or valid Class B driver's license with passenger endorsement and experience in the school bus driving industry.

Traffic hazards.

Driving a vehicle during adverse weather conditions.
