Nyob rau feem 48204 ntawm Txojcai Kawm Ntaww (Education Code) qhia tau tias daim ntaww puavpheej (affidavit) no yog ib qhov tseemceeb siv los mus txiatxim siab txog lub chaw nyob rau ntawm tus menuam, uas tsi tas yuav tsum tau kev tso cai los ntawm tus saibxyuas lossis ib qhov custoday order dabtsi, tshwj yog lub district paub tseeb tias tus menuam ntawd yeej tsi nrog tus neeg (caregiver) ntawd nyob.
2. Lub district yuav tsum tau ntaub ntaww puavpheej qhia tau tias tus neeg uas saibxyuas no yeej nyob rau ntawm lub chaw nyob uas tau hais nyob rau nqi lus nug thib plaub.

Yuav Tsum Muaj Ntaub Ntaww Ua Puav Pheej Qhia Txog Lub Chaw Nyob. Cov Ntaub Ntaww Yuav Tsum Muaj Yog:

Cov tibneeg uas muaj ntaub ntaww nyob rau lub tebchaw no **yuav tsum** muab kom tau **Ib qhov** li nram qab no thiab yuav cuv tau npe kawm ntaww:

- Daim ntaww them se rau lub chaw nyob (Property tax)
 - Daim ntaww them nqi tsev, daim ntaww coglus xauj tsev nyob, lossis ib daim ntaww coglus xauj tsev (lease agreement)
 - Cov ntaub ntaww them nqi (e.g. PG&E, SMUD, nqi dej, nqi khibnyawb, sewer) ntaww coglus, statement, lossis daim receipt them nqi tsev
 - Daim receipt xauj tsev nyob
 - Niamtxiv lossis tus saibxyuas daim tw tshev nyiaj uas nyuam qhuav them (uas muaj lub chaw nyob rau ntawd)
 - Muaj npe nrog lawv pov ntaww xaiv tsa
 - Muaj ntaub ntawv los ntawm nomtsvw tej koomhaum (e.g., muaj ntawv los ntawm Department of Human Assistance, ntaub ntawv tim xam, muaj ntaub ntawv rau lub tsheb, driver's license).
